- 18 thought was dismissed was in fact still pending. She contacted the Board office to inform staff
- 19 that she is the subject of a complaint pending before the Massachusetts Board of Psychology.

- 21 Psychology, the applicant's Motion to Dismiss, and the application file for Florida licensure.
- 22 Pursuant to Section 456.013(3)(a), Florida Statutes, the Board may refuse to issue an initial
- 23 license to any applicant who is under investigation or prosecution in any jurisdiction for an

action that would constitute a violation of this chapter 490 F.S. or chapter 64B19 F.A.C. until

- 25 such time as the investigation or prosecution is complete.
- Following discussion, Dr. Neda Koehnemann moved to reconsider the application. Dr. LuisOrta seconded the motion, which carried 5/0.
- Dr. Luis Orta moved to require a personal appearance of the applicant following completion of
 prosecution in Massachusetts. Dr. Neda Koehnemann seconded the motion, which carried 5/0.
- 30 Dr. Luis Orta moved to require a personal appearance at the next scheduled meeting of the
- 31 Credentials Committee or the Board following receipt of the order from the Massachusetts
- 32 Board of Psychology. Dr. Neda Koehnemann seconded the motion, which carried 5/0.

15 During the October 2011 meeting, Dr. Reiff inquired about the feasibility of reducing initial

16 licensure and renewal fees, based upon review of the most recent Profession-by-Profession

17 Revenue and Expenditure Projections prepared by the MQA budget analyst. It was agreed that

18 further discussion would take place regarding this proposal at the January 2012 meeting.

19 During the April 20, 2012 meeting the Board was provided with the requested fee scenario

20 reports provided by the Department's budget analyst for consideration in regard to the

21 feasibility of reducing initial licensure and renewal fees. Staff was directed to invite the

22 Department's Budget Analyst to participate in the June 2012 Board quorum conference call.

23 During the meeting the Board was addressed by Mendy Simmons, Senior Health Budget

Analyst. The Board agreed to table the discussion until receipt of the most recent budget

25 projections following the close of the fiscal year. The discussion will continue during the

26 October 2012 meeting with a focus on reducing the initial licensure application fee.
