14 **REVIEW OF APPLICATION FOR LICENSURE**

15 **Tab 1** Joseph Cautilli

16 Dr. Cautilli's application has been removed from the agenda.

17 **Tab 2.** Ashok Chhabra Endorsement of Other State License (PA 2010)

18 Dr. Chhabra has requested his application be removed from the agenda.

19 **Tab 3.** Steven David Endorsement of Other State License (CA 2008)

20 Dr. David was not present, nor represented by counsel.

21 Dr. David has applied for licensure under the Endorsement of Other State License method. He has  
22 requested the option of keeping his application open under the Exam with Waiver method if it appears the  
23 committee is moving toward denial under the Endorsement of Other State License Method. Provided for  
24 the committee's review was the application, license verification and the regulations that were in effect in  
25 California at the time the applicant was licensed, as well as the applicable regulations in effect in Florida  
26 during that time.

27 Following discussion, Ms. Mary O'Brien moved to deny the application under the Endorsement of Other  
28 State License method based on the Committee's determination that the education, experience and  
29 examination requirements in the 2008 California regulations were not equivalent to the Florida  
30 requirements during that same time. The Committee will allow Dr. David's application to remain open  
31 under the Exam with Waiver method. Dr. J. Drake Miller seconded the motion, which carried 3/0.
