Tab 1 Daniela Jaramillo Endorsement of Other State License (WI 2001)

Dr. Jaramillo was present and was not represented by counsel.

Dr. Jaramillo has applied for licensure under the Endorsement of Other State License method. Provided for the Committee's review were the application, license verification and the regulations that were in effect in Wisconsin at the time the applicant was licensed, as well as the applicable regulations in effect in Florida during that time.

Following discussion, the Committee determined that the education and experience requirements in the 2001 Wisconsin regulations were not equivalent to the Florida requirements during that same time. Due to the Committee moving toward denying the application, Dr. Jaramillo requested to withdraw the application.

The committee was also concerned about her criminal history. Dr. J. Drake Miller moved to request a personal appearance. Ms. Mary D. O'Brien seconded the motion, which carried 3/0.
